About the Speakers: Dr. Melkers is a 1994 graduate of Marquette University School of Dentistry & currently serves as visiting faculty at Rīga Stradiņš University Department of Prosthodontics & The Pankey Institute, where he also serves on the Board of Advisors. He is the former Director of Occlusion & Aesthetic Dentistry at the Pacific Northwest AEGD Residency Program and Visiting Faculty at The Spear Institute. Dr. Melkers is a Master of the Academy of General Dentistry and maintains a private clinical practice in Hanover, NH; with a focus on comprehensive adult restorative care. Dr. Ochi graduated with honors from the University of Southern California in 1981, and is a Fellow in the American College of Dentists and the International College of Dentists. He is currently an Associate Clinical Professor in the Department of Restorative Dentistry, and was the Co-director of Occlusion at U.S.C. School of Dentistry. Dr. Ochi is an Assistant Director in the Advanced Restorative Institute Dental Education Center and maintains a full time private practice in Beverly Hills with an emphasis on physiologic and aesthetic reconstructive dentistry.
